

## OV Drop-off Information

Parents/caregivers or other designated adults are encouraged to transport their children, whenever possible, to minimize the number of students on the bus.

1. Students entering from the parking lot (including Stafford students):
  - ★ Go to the large cafeteria entrance to be screened and enter through the large cafeteria.
  - ★ Stafford students go immediately to the bus on the North side of the building.
  
2. Parents/adults dropping off students:
  - ★ Drive across the front of the building, students will exit at the stop sign and be screened by the East wing entrance.
  
3. Students arriving on the bus:
  - ★ Will be let off in the back of the building at the music wing entrance and be screened there (Stafford students go immediately to the bus on the North side of the building).

## Exclusion from School

Students or staff will be sent home as soon as possible if they have any of the following symptoms of COVID19:

• Cough • Fever (100.4 or greater) • Shortness of breath • Chills • Fatigue • Muscle pain or body aches • Headache • Sore throat • Loss of taste or smell • Congestion or runny nose • Nausea, vomiting or diarrhea (diarrhea is defined as frequent loose or watery stools compared to child's normal pattern)

**Students and staff will be excluded from school until they are no longer considered contagious.** The student's healthcare provider may be consulted to help determine what medical course to take.

*Students and staff with fever greater than 100.4°F and no specific diagnosis should remain at home until they have had no fever for 24 hours without the use of fever reducing medications (e.g., Advil, Tylenol).*

## Student Mask Information

**All students are required to wear facial coverings while on the bus**

**and in the building. They must wear them when outside the building**

**if adequate physical distancing cannot be maintained.**

RNESU schools are able to provide students with cloth face coverings upon arrival at the school:

- If your child is waiting at the school bus stop without a mask, the bus driver will supply your child with a mask.
- If your child was given a mask on the bus, then upon arrival to the classroom, your child will be given the option to change to a cloth face covering.

If you choose to supply your child's own face coverings:

- Please send an extra so that it may be changed in the event it becomes soiled or wet.
- Masks should be made of fabric at least two layers thick OR a medical/surgical mask.
- The mask must cover the nose and mouth.
- Bandanas, masks with open bottoms or scarves are NOT considered suitable facial coverings.
- Only 2 ply cotton or poly/cotton blend gaiters are allowed.
- Face shields may be worn as eye protection over a mask, but a face shield alone is not acceptable.
- Masks with exhalation valves or vents will not be allowed as these allow droplets to be easily released to others.
- Long ties are not recommended for younger students as they pose a choking risk, ear loop styles are preferred.

Mask adherence:

- If a student removes their mask and refuses to put it back on, every effort will be made to determine the reason and encourage the student to replace the mask. This may include an assessment and/or intervention by the school nurse, guidance counselor, or school administrator as appropriate.
- If necessary, a parent/guardian or emergency contact will be notified that the student will need to be picked up.
- If a student consistently refuses to wear a face covering, they will not be permitted to attend in-person learning.

Mask exemption:

- If your student has significant medical circumstances which would prohibit their use of a mask, please contact your child's medical provider and the school as soon as possible for further discussion. No one will be permitted into the building without a mask for any reason unless a proven need has been identified in writing by a medical provider and approved in advance by RNESU administration and the healthcare team.
